FIRE DANGER- BUFFELGRASS: Your Cooperation is Needed!

At our Annual Meeting, on March 30th, there was mention and some concern about BUFFELGRASS. This is a fast-burning and very dangerous type of grass, and we all must cooperate, because once it starts burning, it spreads very quickly. Ken Cooper met with the Northwest Fire Department on Wednesday, April 29th, and they agreed to do a "ride around" our neighborhood, to look for fire danger. On Friday May first Bill Jones and Ken Cooper drove around the neighborhood,

with the fire truck following us, and we stopped in front of many homes that had buffelgrass by the roadside. We toured most of the streets in our Homeowners' Association. We also noticed buffelgrass in the adjoining association and will notify their Board so they can be aware of this concern.

In case you do not know what buffel-

grass is, or what it looks like, there is a website, <u>www.buffelgrass.com.</u> Please review this and pull out any buffelgrass on your property and suggest to your neighbors that they do the same. If we all cooperate, we can lessen the fire danger significantly.

Bill and Ken noted the homes that appeared to have buffelgrass by the roadside. This list is reprinted below. Please cooperate, and do your part in removing this dangerous fire hazard. Here are the addresses of known buffelgrass in the subdivision: Paseo de las Colinas- 4941; Paseo del Barranco5100; **Paseo del Campo-** 5100, 5140, 5165, 5160, 5115; Placita de Arriba-4050, 4085; **Paseo de las Estrellas**- 4940, 5011, 5020; Paseo de los 4950, Rancheros- 4030, 4040, 4102, 4141, 4211, 4200, 4225, 4255, 4300, 4301, 4310, 4311, 4320, 4325, 4330, 4340, 4380, 4521, 4541, 4601, 4621, 4651, 4661, 4871, 4681, 4700, 4715, 4720, 4765, 4760, 4700, 4715 and 4755.

Everyone please understand that this was done just by a quick drive-by by your President and Vice-President and is only a visual inspection from the street. You may have more bufflelgrass in

> areas we did not see. What we did observe is that most of the problems seem to be on Rancheros along the road, and most of what we did see is probably not even on the property of the above addresses, but in the public right-of-way. No matter the technical "owner" of the land where the grass is located, it is your house that

burn down if it is not removed and a fire occurs.



Since our Board felt that **most** people in our Association did not want to give up the second day of garbage pickup, just to get wheeled recv-

čle bins, we told Waste Management to keep things as they now are.

Unless we have written requests from a majority of the homeowners requesting the larger wheeled recycling bin in lieu

<u>Treasurer's Report:</u> At the time of the report, we had \$6,277.54 in our account. Two homeowners have dues two years or more past due, and one,
