pay your dues. They do charge a service fee of \$1.00.

What do we do ?

For those who are new in the HOA, this question often comes up, and even those who have been here for a while may wonder, so here is a brief listing of but some of the things we do:

1) Send out a quarterly newsletter to inform our residents of what is going on, what things to be aware of, and

> upcoming events. 2) Maintain and upgrade our websitewww. RanchodelCerro. ora. The architectural

request form, former newsletters,

and a list of neighborhood referrals, as supplied by our homeowners, are

on this site as well as our Bylaws, and a copy of our CC&R's.

3) Sending out e-mail blasts as the need arises for urgent situations. In the past, this has included warnings about snakes coming out ear-

ly in our area, as well as some car break-in situations.

4) For the last few years we have combined our Annual meeting with food. The HOA has supplied hamburgers/buns and all the trimmings, and the members have supplied other items to share. We have also had guest speakers, including two Pima County Sheriffs, a Northwest Fire Dept. representative, a Pest Control expert, and a representative of the

5) For the last five years or so, we have held an Annual Community Yard Sale. We need at least 10 homeowners to participate as there is a lot of work involved for The Board to put on this event. One year we only had four respondents and could not hold it.

6) Contact with the County: As you know, our streets are serviced by the County. Often I have been contacted by residents about 'potholes', trimming of county vegetation near the roads, or other similar problems. I have developed special contacts with the County and have more 'pull' than an individual calling into them. The County has responded in each case, and have resolved the problems cited within about three to four weeks.

7) Architectural Control: Our CC&R's require that all outside work be it the building of fences, painting of your home, or other outside work on your property require the approval of the ar-

chitectural committee. In almost all cases, these issues are approved, and resolved, with the approval of the Board. By the way this requirement for HOA approval applies even if you are not a member of the HOA, as it is a requirement of the CC&R's.

8) Lighting of the solar signs at corner of El Camino del Cerro and Paseo de los Rancheros. This past
